Agent Orange & PTSD Update:

AGENT ORANGE: On August 31, 2010, VA published the final regulation establishing all chronic B-cell leukemia's, Parkinson's disease, and ischemic heart disease as related to exposure to Agent Orange and other herbicides. Veterans diagnosed with these diseases will only have to show they were in Vietnam sometime between Jan. 9, 1962 and May 7, 1975, to qualify for service-connected disability ratings and compensation. PTSD: The VA's new rule regarding Stressor Determinations for Posttraumatic Stress Disorder (PTSD) would not require corroboration of a stressor related to fear of hostile military or terrorist activity if a VA doctor confirms that the stressful experience recalled by a veteran adequately supports a diagnosis of PTSD and the veteran's symptoms are related to the claimed stressor. Previously, claims adjudicators were required to corroborate that a non-combat veteran actually experienced a stressor related to hostile military activity. This final rule simplifies the development that is required for these cases. VA expects this rulemaking to decrease the time it takes VA to decide access to care and claims falling under the revised criteria.

DAY ONE AND COUNTING

Randolph at Hill 55 near Da Nang on his 2nd tour in1969:

My journey to Southeast Asia began in March, 1964 with platoon 325 at the Marine Recruit Depot in San Diego. Our Drill Instructor would read to us about Vietnam and predicted that 60% of us would be killed there. My next —good time news about same was June, 1965. I was embarked aboard the USS General W.M. Mitchell, a troop transport ship in the middle of the Pacific Ocean. I had orders for the 3rd Marine Division on Okinawa and not the 60% place called Vietnam.

When they opened the door of the C-119 transport plane in Da Nang, a wave of humid heat hit me. It was like nothing I had experienced before. I had grown up in south Texas and this, by far held a pat hand on bad air. The additional combination of spent brass, gun emplacements, barbed wire and my assignment to a unit —outside the wire was beginning to look like a highway to hell. That road took me through —Dog Patch and on to a dried up a dried up rice paddy area known as a —CP. It was surrounded by a platoon of M-48 tanks and a battery of 8 inch howitzers on tracks.

I reported in to the company CP and was issued an M-14, bayonet, two canteens, and two hand grenades, half a dozen magazines and ammo for same. They told me I would be leaving for Chu Lai in a day or so. And this gear was sufficient for the time being. A Private First Class does not get the silverware of the rich and famous or assigned a suite. My quarters for that night amounted to a crate filled supply tent and a half full case of C-rations. The rats were the only entertainment that first night. Their show was not taken too lightly either. I found a crate large enough to sleep on at a safe distance from that rodent dance.

A sergeant from the CP came by and told all the FNGs which fighting hole to man if we were attacked. When the sun faded away the night light of the moon illuminated my surroundings and the shock of being here set in. I ate some C-rations and attempted a short time later to sleep. This was not to be. I heard the scream of a Marine and small arms fire erupted. It was a short burst that sent a dozen Marines making a mad dash to their fighting holes. I found myself in one trying to make some sense about me. The perimeter fighting holes were manned and stayed that way for the remainder of the night. An M-48 tank began a sweep outside of our perimeter. I was definitely glad it wasn't on the hunt for me.

An M60 from a line company to our left opened up with a 20 round burst. A lot of noise from our, side but still no incoming fire was received. This was not the John Wayne movie of war that I had seen in the theaters back home. The call came just before daybreak to stand down. In the morning I learned that one of our sentries had been jumped by the VC and knifed. He would be okay. The line company to our left was not so lucky. They had one Marine dead. He was killed by friendly fire.


A Letter from One of our Scholarship Winners:

I never thought my written words could or would evoke such emotion but I am glad your family was able to connect with me and I feel truly honored to have been a part of a group of so many miraculous people even if it was for one night. You have impacted me in a way I doubt I will ever be able to put into words. I know that the trials of my life are nothing compared to what many of you have been through but I will continue to live my life with the thought of you and the people like you in my heart and in my head. You are all heroes. Just know that it is never too late to get a warm welcome and just due. You will never be forgotten, of that you can be sure. From the bottom of my heart, WELCOME HOME!!!
