When I first became pastor of the North Fork Assembly of God in North Fork, California, I held an appreciation dinner for my Board Members and all our volunteer Sunday school teachers at the Pines Resort at Bass Lake. We had a tritip dinner and I awarded our Sunday school teachers a certificate of appreciation for their faithful service. I always feel that it is important to encourage volunteers by recognizing their devotion and work. Much to my surprise though this dinner had the opposite effect than what I was expecting. Except for the Board Members, all the teachers quit. They felt with the dinner that their job was done and now it was for someone else to step up. They believed that the new members of the church should take over. Here were experienced, dedicated people telling me that we should have inexperienced, untried people teaching the most important resource of the future of the church, our children. I could only attribute their desire to quit to burn out. They felt that finally, someone appreciated all their hard work so they would quit while ahead.

I had, and still have, a difficult time with those who volunteer then quit before the task is finished. My personal commitment when I volunteer for anything is based on a few things. The first principle is found in the Bible at James 4:17 which states, "Therefore, to him who knows to do good and does not do it, to him it is sin." The second principle is found in the quote of Edmund Burke, "The only thing necessary for the triumph of evil is for good men to do nothing."

The third principle is knowing it is not the person who starts a race that wins, it is the person who finishes, no matter how difficult or how long it takes. I have always desired to finish well.

I sometime go back and remember an oath I took in 1966. You may recognize it yourself. "I,\_\_ solemnly swear that I will support and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; and that I will obey the orders of the President of the United States and the orders of the officers appointed over me, according to regulations and the Uniform Code of Military Justice. So help me God" 1 I may not have to "obey the orders of the President of the United Staes and the orders of the officers appointed over me," but I will always "support and defend the Constitution of the United States against all enemies, foreign and domestic and that I will bear true faith and allegiance to the same". One way I dedicate myself to this principle is by working with and for veterans and active service personnel of all the services in whatever capacity I can.

One person cannot do everything. We must all share the burden so that we don't burn out. If there is a hundred pound burden to be carried, ten people carrying ten pounds each or better yet one hundred people carrying one pound each can travel much farther than one person carrying the whole load. If you see a need it just may be you are the one to meet it.

# Scam Alert: Top Five Veteran Swindles

Swindlers target vets because they know they are drawing guaranteed benefits. While veteran payments are paid over a lifetime, they often aren't enough to pay all of the bills. Financial predators know this.

According to the <u>AARP Fraud Watch Network</u>, there are a host of scams aimed at vets. Many of these operations masquerade as charities that claim to benefit vets. Here are the major scams:

Bogus sales – "A scammer claiming to be a deploying service member posts a large ticket item on a classified ad website that he needs to sell right away and at a steep discount. The scammer asks for upfront payment with a wire transfer or gift cards.

**Real estate rip-off** – A scammer posts a fake rental property on a classified ad website offering military discounts. You just need to wire transfer a security deposit to the landlord.

VA phishing – A caller claiming to be from the Department of Veterans Affairs calls to "update" your information.

**Fake charities** – Fake charities use names that are close to the names of legitimate charities, often referencing Armed Forces, veterans, or military families.

**Benefits "buyout"** – Scammers will target veterans in need of money by offering cash in exchange for their future disability or pension payments. These buyouts are typically a fraction of the value of the benefit.

**Dubious investment advice** – An "adviser" will tell the veteran she is missing out on benefits, and wants to review her investment portfolio. He'll then want to put the veteran's investments in a trust, to appear to have fewer assets and to therefore be eligible for an additional pension."

Note: The "benefits buyout" scam also goes by the name of "pension advances." A company will offer to "buy" monthly pension payments in exchange for a lump-sum payment. It's actually an unregulated, high-interest loan.

Everyone that wishes to volunteer to assist those visiting the wall is obligated to attend a training/introduction session. The purpose of the training sessions is to familiarize the volunteers with the specific data and history of the memorial, and the proper and acceptable behavior by all visiting The Wall, and assisting with finding names or helping with rubbings. The work will entail using a computer provided at the site to search for names in the VVMF data base and assisting out at the wall to answer questions and assist the visitors.

Again I would like to thank you in advance for wishing to participate in this event. I would appreciate an RSVP as the room can only holds 80 people.



# Agent Orange

Agent Orange was used in Vietnam to kill unwanted plants and tree leaves that provided cover for the enemy. One of the chemicals in Agent Orange had traces of dioxin, which may cause cancer and other diseases. The US government is currently researching the health effects of Agent Orange. Vietnam veterans can participate in the Agent Orange registry program, to help monitor their health.



# Effects of Agent Orange

Dioxin, one of the components of Agent Orange, has been linked to Hodgkin's disease, prostate cancer, lung cancer, multiple myeloma, chloracne (a skin disorder), neuropathy (a nerve disorder) and type 2 diabetes. Children of female Vietnam veterans may have higher rates of spina bifida, a birth defect.

# What Veterans Can Do?

The Agent Orange Registry program was set up in 1978, to monitor the health of Vietnam veterans. Contact the nearest VA to schedule an entry examination. Patients are asked a series of questions about their exposure to herbicides in Vietnam. Doctors will then take a medical history, perform a physical exam, and complete lab tests.

The VA assumes exposure to Agent Orange for Vietnam veterans. The VA will determine eligibility for compensation for health problems that are service- connected.

# Frequently Asked Questions

What if I Served in Korea? Since Agent Orange was also used in Korea in the late 1960's, Korean War veterans can also get Agent Orange exams. Please contact your VA primary care provider.

How Do I Know if I was Exposed?
The VA assumes that most
Vietnam veterans were exposed,
since Agent Orange was used all
over. The Agent Orange exam can
help monitor your health so that
you can treat and prevent any
possible health effects that
resulted from your exposure.

Who Do I Contact at the VA?
At each VA there is a "Registry
Physician" that provides the Agent
Orange Exams. These physicians
receive the latest information about
Agent Orange and dioxin.
