Joe Reyes – I have a memory of something that happened to me many years ago, which I still think about when the subject of fish is talked about. I have enclosed it and hope it's worthy of being printed.

A Fish Story - November 25, 2020

Back in 1990 I lived in El Rio in a two bedroom house that was small, but comfortable. The kitchen had a door to the back yard where I had a makeshift grill where I would usually BBQ or cook fish so I wouldn't smell up the house.

In El Rio there are lots of neighborhood cats that would roam through the back yards looking for handouts, which I often provided something being I like cats.

One weekend my brother-in-law brought me a nice sized trout for me to cook for lunch. I was so excited about the fish that I made a fresh green salad, cooked some white rice and chilled a bottle of white wine to compliment the entre. Only a couple of minutes passed so I casually return to see how my fish is coming along. I'll be damned! About a dozen neighborhood cats had turned my trout into a buffet. The aluminum tray had been dragged off the grill, which was only about a foot off the ground and my trout or the carcass lay on the grass with chucks bitten off. In my rage to chase the cats away I threw a broom at them. Of course I missed the cats, but I was able to hit the TV tray that held my salad and bottle of wine, they tumbled onto the grass. I yelled and cussed loud enough that I got the attention of my neighbors.

It took a couple of minutes to cool down and breathe a little easier, but when I did I caught a whiff of something in the air. I rushed to the kitchen and found that my white rice cooking was now the color of mud.

Disheartened, I grudgingly went to plan B for lunch. As I sat on the steps of the back porch and surveyed the remnants of the trout lunch, I felt heartburn coming on as I drank a cold beer and ate an equally cold Spam sandwich.

Our organizations primary function is to act as a 'service' group providing all manner of assistance to our veteran population. We are active in the education of our youth in our local schools by speaking at the schools to the students. We support and provide college scholarships every year. We have been the organization responsible for bringing the 'Traveling Wall' Vietnam Memorial to Ventura six times in the last 30 years and are planning on doing so again in 2018. We provide full military honor and color guards in parades and at funerals. We work closely with literally hundreds of other organizations and our elected officials both State and Federal in the county to see veterans' needs are met.

Our group runs around 130 strong, most living in Ventura, but some as far away as Australia and Canada. We are asking for donations to our cause, by selling advertising space in our newsletter.
